HHSC Advisory Committees of Interest 2022 Committee Engagement Levels and Process

Process for Selecting Committees of Interest

- THBI will biennially poll the State-Federal Legislative Committee for their feedback on which HHSC advisory committees to track and monitor.
- THBI will collect feedback, assign committees to engagement levels, and present the recommendations to the State-Fed Committee for approval.

Proactive Engagement Level

Committee tracking and monitoring will consist of:

- Providing committee meeting notices to State-Fed Committee members
- Attending committee meetings
- Summarizing committee meetings and providing the summary to State-Fed Committee members
- Monitoring for items and updates of interest within committee reports
- Engaging with the committees to advocate, support, or promote issues of interest within the committee meeting agenda
- Providing interim committee reports to State-Federal Committee upon release

Strategic Monitoring Level

Committee tracking and monitoring will consist of:

- Providing committee meeting notices to State-Fed Committee members
- Attending committee meetings if agenda items include items of interest to industry
- Monitoring for items and updates of interest within committee reports
- Engaging with the committees to advocate, support, or promote issues of interest within the committee meeting agenda
- Providing interim committee reports to State-Federal Committee upon release
