<u>Call to Order, Welcome and Opening Remarks</u> – Natalie Vanek, M.D., Committee Chair. The meeting was called to order by the Chair.

Logistical Announcement and Roll Call – Sallie Allen, Advisory Committee Coordination Office, HHSC. A quorum was established.

<u>Consideration of January 29, 2021 and April 30, 2021, meeting minutes</u>. The minutes were approved as written.

<u>Department of State Health Services Updates</u> – Imelda Garcia, MPH Associate Commissioner.

- The program was moved back under Ms. Garcia
- Pharmacy Branch reports now directly to the division
- Internal Audit Report was released, and they are working to address the 73 recommendations
- \$36 million was appropriated by the Conference Committee and additional GR was provided for the medications program



- We have to look at client growth and cost growth. Cost containment measures may have to occur.
- We are in a holding pattern on the spend down
- Changes to rider 26 expands upon insurance purchasing but this was struck by the legislature but some of the provisions in the rider will be moving forward for transparency.

Questions/Answers/Comments

Will TIAP still be offered (Insurance Assistance)? DSHS stated that the intent is to honor those already in the program, but no expansion is anticipated. If HRSA agrees then they may extend the grace period.

State Budget Year (BY) September 1-August 31 annually. Obligated funding is on a PO for the current BY.

Due to rebate shortfall, BY2021 has one-time funding from other DSHS appropriations in addition to Coronavirus Relief Funds that are not typically available within this appropriation including the \$1.5M GR fund.

Due to the infusion of CRF funds, an estimated \$30M of the \$50.4M in BY21 'obligated' HIV Care Formula Grants will roll forward from BY 2021 to BY 2022 September 1, 2021.

Total EI for FY22 is \$8,164,958 and same for FY23

EI is represented in FY22 budget as, Fund 001 for \$5,693,151 and Fund 8005 for \$2,471,807



June 30, 2021 Partnership Meeting

- 276 stakeholders registered and 198 attended the meeting
- Imelda Garcia, Associate Commissioner, of the Laboratory and Infectious Disease Services (LIDS)
 Division was also in attendance
 - TB/HIV/STD Section is back reporting to LIDS
- Exceptional Item (EI)
 - 36.3 million awarded from the 87th Texas Legislature
 - · 16.3 million for medications
 - · 20 million for restoration of Ryan White, HIV Prevention, and Public Health Follow-up Contracts
- · Rider 26
 - ADAP cannot be used for health insurance expansion
 - Texas Insurance Assistance Program (TIAP) can continue and accept new clients as eligible
 - · Any changes to the Texas Administrative Code (TAC) will require the community be notified 60 days in advance
- · DSHS does not plan to implement a waitlist for the next biennium

June 30, 2021 Meeting Updates

- Spenddown/ Standard Deduction
 - · Potential need to remove the spenddown
 - Later introduce a standard deduction once the TAC is updated
- The pharmacy warehouse is now reporting directly to the LIDS Division
- Take Charge Texas Portal
 - Rollout end of 2021
- Medication formulary changes
 - DSHS Commissioner approved the suspension of 17 medications
 - Cabenuva pilot delay
 - Daraprim back in stock
- THMP working overtime to address the backlog
- Implementation of full THMP recertification process
 - Need to stay compliant with grant expectations following relaxed COVID eligibility

Questions/Answers/Comments

Does this consider cost and client growth? DSHS stated that this has sufficient funding for 2022. Opportunities for supplement funding will be available as well.

This is a good budget report compared to those in the past.

We are operating under a "Just in time model" and as such we do not keep stockpiles of inventory on the shelf.

The CDC numbers for HIV in Harris County are down and is this the experience across the state? DSHS stated that the Texas numbers are different. 2020 was strange because of COVID.

<u>THMP Update - Rules change, Projections and demographic information, Long-lasting injection medication update</u>. Rachel Sanor, THMP Manager



Texas HIV State Pharmacy Assistance Program and Texas HIV Medication Program Title 25, Chapter 98, Subchapters A and C, Division 1

- · Rules change includes the following:
 - Includes the Texas Insurance Assistance Program (TIAP).
 - Merges State Pharmacy Assistance Program (SPAP) and Texas HIV Medication Rules into one set of rules.
 - Removes a specific FPL from the rules, this will be determined at the department level instead.
 - Removes spend down and replaces it with a standard deduction.
 - Updates language to reflect current structure of program.
- The informal comment period was extended from July 7th to July 16, 2021.
- A second, formal comment period will be when they are posted on the Texas Register for 30 days.













SPAP Projections







Questions/Answers/Comments

Every year except 2020 the cost tracked along with prescriptions. In 2020 the cost was up but the prescriptions were down. DSHS stated that the COVID response skewed the data.

Backlog of ADAP applications. DSHS stated that there is a back log in the program and the self-attestations are still processing. The back log should be taken care of.

People do not know their medications are being with-held until they get to the pharmacy. DSHS stated this is a concern and they are working on the issue. Self-attestations are being certified by staff and there is a need for additional staff. The C OVID extension ends at the end of next month.



<u>Procedure for Election of New Officers</u> – Sallie Allen, Advisory Committee Coordination Office, HHSC. The HHSC committee standard procedures were reviewed for the election of officers next meeting.

<u>Sub-Committee Reports</u> (Formulary Sub-committee – Natalie Vanek, M.D; Governance/Data – Nancy Miertschin; Eligibility – Frank Rosas). *There appeared to be a lack of preparation for these presentations.*

Formulary: The presentation was muffled and could not be understood. They talked about a pilot project and left it on the table. They discussed medication suspension for the ten medications suspended. They discussed a provision of three-month supply to prepare people for the transition. They were still waiting for the program funding information and as such suspended the 90 program.

Governance/Data: There have been three meetings. On May 28th they developed a statement and streamlining the certification form online, and that is ready to go. There was discussion about budget issues and preparing for new members. They received numerous updates. The pharmacy warehouse budget was discussed. Different items that were updated today at the meeting were requested. There was a desire for more transparency on how medications are added and also eliminated.

Eligibility: The July meeting was cancelled. The previous issues are available through the official documents for this meeting (*which were not provided to the public*)

<u>Public Comment</u> No public comment was offered.
